

TERMS AND CONDITIONS FOR GET HANDICAP@SIME PROGRAMME DEFINITION AND INTERPRETATIONS

“Get Handicap @ Sime”, also known as GHS, is a programme managed by Keppel Club and is offered to public golfers without a golf handicap and are keen to get one and have it maintained with Keppel Club.

“Participant(s)” means a person of the public who is not a member of Keppel Club and who has joined the Get Handicap@Sime Programme.

“Centralised Handicapping System”, also known as CHS, is an online system for golfers to update their scores and maintenance of their handicap index.

General

1. The cut-off date for the handicap revision will be on 25th of every month. Any scores submitted after the said date, the handicap will be revised in the following month.
2. It is the responsibility of the participant(s) to post their score after their round of golf. Keppel Club shall not be responsible for any penalty score on the participant(s)' score due to late submission, in accordance to the rules and regulations set by Singapore Golf Association.
3. The participant(s) of the GHS managed by Keppel Club shall not be liable for any issues pertaining to the CHS such as, but not limited to, a computing error in the system.
4. All 9-hole games at Sime course are on a first-come, first-served basis, subject to availability.
5. There will be strictly no refund upon application and receipt of payment for GHS.
6. The self-learning of Golf Etiquette (theory) is the responsibility of all participants of GHS to read and understand this theoretical portion of the programme.

Submission of Scores

7. The participant(s) shall be responsible for their submission of scores via CHS.
8. Participant(s) are encouraged to submit their scores within 14 days from the date of play. After the 14th day, participant(s) will be required to send an electronic mail to membership@keppelclub.com.sg for the submission of scorecard.
9. Participant(s) should check the validity and accuracy of the scorecard before submitting to Keppel Club for posting of scores on the CHS.

10. Should there be any changes in the details of the scorecard submission process, Keppel Club will inform via electronic mail to keep the participant(s) updated. Therefore, it is the responsibility of the participant(s) to be updated on the prevailing terms and conditions.
11. Get Handicap @ Sime Programme participant(s) agree that Keppel Club reserves its rights to make changes and/or to amend any of the terms and conditions herein without reason or notice to be given to the Get Handicap @ Sime Programme participant(s). Therefore, all Get Handicap @ Sime Programme participant(s) are strongly encouraged to check the prevailing terms and conditions to update themselves.
12. The participant(s) account holder hereby agrees that all or any dispute and/or determination and/or interpretation and/or decision pertaining to the Get Handicap @ Sime Programme including but not limited to the terms and conditions herein shall be solely within the discretion of Keppel Club and any decision and/or determination taken by Keppel Club for this Get Handicap @ Sime Programme shall be final and deemed proper and accurate.
13. The Participant acknowledges that he/she has read the terms and conditions and understands their intent and purport. By signing this agreement, the Participant explicitly waives any rights to claim inability to understand the English language in the future in relation to this agreement. The Participant further affirms that he/she possesses an unequivocal and absolute understanding of the English language. It is advised that the Participant seeks legal counsel to fully comprehend the terms and obligations of this document before signing.
